# Vet to Vet ME's Major Milestones in FY23

In our fifth year as an independent nonprofit, Vet to Vet Maine continues its important work serving Maine Veterans.

#### Some of the year's highlights:

- V2VME founder/executive director Susan Gold and Lynn White, V2VME incorporator and the organization's first president, step down from their respective posts.
- New England Patriots honor V2VME Peer Companion and board member Sam Kelley and donate \$10,000 to Vet to Vet Maine.
- Three new staff members join V2VME: Maggie Catanese (Outreach Director), June Budrow (Administrative Assistant), and Melissa Chason (Volunteer Coordinator).
- V2VME is awarded \$20,000 in American Rescue Plan Act funds to support our mission to reduce social isolation and enhance community and connections for older veterans and their caregivers.
- V2VME receives funds from United Way of Southern Maine (York County region), Cumberland County Community Development program, Drummond Woodsum law firm, two anonymous foundations, Shutterbugs 4 Charity, 100+ Women Who Care, City of Saco, South Portland and Cape Elizabeth Rotary Club, Construction Golf League, and Eddie Woodin's Challenge Fundraiser, along with generous gifts from our donors.
- The Caregivers Support Network hosts its annual Roll-A-Thon with a luncheon, cake, and a stroll and roll along the Shaw Cherry Hill Farm trail in Gorham, topped off with Beal's ice cream sundaes.
- We are finally able to hold in-person case reviews for our Peer Companions, thanks to the generosity of the Scarborough American Legion Post 76, which provides a meeting space. The gift of an OWL computer from the Biddeford Adult Education program enables those at home to view and participate in the case review. Biddeford-Saco Rotary Club and its president, Martin Grohman, arranged for the OWL.

From July 2022 to June 2023, Vet to Vet ME Peer Companions devoted more than 2,800 hours to 110 Veterans who needed a friend. Other Volunteers spent nearly 1,700 hours supporting V2VME caregivers and the organization's mission.



# Companionship Built Upon Respect

Vet to Vet Maine's fifth year as an independent nonprofit—and the program's eighth year since its inception in 2014—continues to be filled with remarkable stories of the power of friendship. The story of Lou and Ron shows how going the extra mile—a visit, a book, and fresh air—can be the highlight of one's week.

Louis Léveillé still exemplifies the Air Force core values he committed to in October of 1950. The 91-year-old Korean War Veteran continues to put "service before self" as he volunteers his time with V2VME as a

peer companion to fellow Veterans who need a friend. Since 2014, V2VME volunteers have eased Veterans' social isolation, while linking them to services that can improve their lives.

Lou joined the organization six years ago and was matched with Ron, a Navy Veteran, who is six months his elder and legally blind. Lou began making regular visits to Ron's home, stopping by at least once a week and sometimes more often. The two became fast friends, going out for coffee, swapping stories, and spending time together. As Ron's health deteriorated, Lou and the Vet to Vet Maine staff helped him to arrange for home health care, provided advice on getting into the Maine Veterans' Home in Scarborough, and looked into getting Ron an electric recliner. Ron moved to the Veterans' Home in 2022.

These days, Lou makes the 86-mile round-trip drive almost weekly from his home to the Maine Veterans' Home in Scarborough to pick up Ron. The two load into Lou's car and set off for the local doughnut shop, where they enjoy coffee and a treat. Eventually they park near the beach, where Lou reads aloud to Ron for hours. The ocean air and Lou's voice fill the car. To judge from the smiles on the two Veterans' faces, it would be difficult to determine who is benefiting more from this companionship, Lou or Ron.

It's the same for many of the 60 or so peer companions in Vet to Vet Maine, who often say they get as much out of the relationship as the Veterans they visit. Floyd Hastings, another longtime Vet to Vet Maine peer companion, says of his experience in the program: "This is the best thing I've ever participated in. We both enjoy the visits so much. They help give meaning to my life [and] are the highlight of the week for both of us!"

# V2VME Staffer Judie Alessi O'Malley: A Constant Presence

Before I worked for V2VME, I was a volunteer coordinator at Southern Maine Agency on Aging. V2VME founder Susan Gold learned that I had been furloughed from SMAA in March 2020 due to the pandemic and asked if I would consider taking a job with V2VME as program director. I began my tenure with V2VME just after July 4, 2020, and still love my job after three years.

My father was an Army veteran and served in Europe during WWII. Like many, he didn't talk much about his service. Mom told me the sad stories, while he told the funny ones. After the 2018 Honors Ceremony, I strolled through the Maine Military Museum and was struck by the souvenirs GIs brought back home. I was reminded of my father's beautiful handmade box from the former Czechoslovakia with a wood burned image of a town he was stationed in on the lid. A Czech fellow who befriended Pop gave it to him. When I got home from the event, I looked up the town online and it still looked exactly like the image on the box. During a 2019 vacation to Ger-

many, my husband and I spent two days in that town, Husinec, exploring the same streets my Pop walked as a kid in his 20s. It was one of the most meaningful experience in all my travels. Ever. And, I thank V2V for inspiring me to go there. My father would have loved this organization and loved to know I visited Husinec. I think of him often in my work.

One of the most rewarding matches I made was with Peer Companion Trevor Engling and Mike. Mike called Sue and was in distress. He had dropped out of college and was feeling awful. Trevor, a USM student, was a new volunteer. The match was a success for several years, and we were told by Lorrie Spaulding, USM director of the Military-Affiliated Student Hub, that the match helped change Mike's life, and he returned to classes. Both Trevor and Mike have moved on, but it was so rewarding to help someone who was clearly in distress to find his footing again.

There isn't a typical day at V2VME, except for the golden retriever puppy at my feet who needs to go out every two hours. I have each day planned, but the plans never seem to play out as expected. Generally, I onboard volunteers, veteran friends, and do matches. However, I field all kinds of questions from volunteers, veteran friends, and the public about services available and where to go for help. I follow up on nearly every issue a volunteer alerts me to, which means interacting with the VA, Maine Veterans' Homes, Maine Bureau of Veterans' Services, SMAA, Preble Street, and a myriad of other agencies providing services to people in need. We are also setting up veter-

# Honors Ceremony Celebrates Volunteers

Seventy-five Veterans, volunteers, staff members, and friends gathered on June 10 at the Maine Military Museum to honor retiring executive director/founder Susan Gold and president Lynn White and pay tribute to the volunteers who keep the organization running.

Lynn White, a V2VME incorporator and the organization's first president, reminisced about his experiences with three Veterans, whom he visited regularly as a V2VME peer companion. One, a merchant marine, lived almost 100 years and shared stories about his experiences during the Normandy invasion in World War II. Lynn joined Vet to Vet in 2015, served on the Shared Leadership Team, and led V2VME's transformation from a program at Southern Maine Agency on Aging to its current status as an independent nonprofit.

To honor him for his service with V2VME, the board presented Lynn with a plaque featuring a parable and an image from a needlepoint created by the wife of a V2VME Veteran.

The attendees also honored V2VME founder Susan Gold as she steps down from the executive director position, a position she held as a volunteer since V2VME's incorporation in 2018. Incoming executive director Maggie Catanese and program director Judie O'Malley presented Susan with an engraved wind chime and words of gratitude for her service.

Susan recognized five veterans who attended with their peer companions and presented certificates of appreciation to 36 volunteers, including seven board members, who have dedicated many hours to V2VME. The audience gave special recognition to two members of the first peer companion team who attended the ceremony, Ernest Merritt and Robert Ferrante. Ernie donated an exquisitely hand-carved cribbage board to the event's raffle, which was won by peer companion Paul Kelly.

Guest speaker Lance Corporal Norman VanCor spoke about his experiences as a Vietnam combat Veteran as recorded in his book, "Swift. Silent. Deadly." Copies of the book were distributed to all V2VME volunteers in attendance, thanks to the generosity of an anonymous donor.




